PAL believes in supporting our youth year-round, which includes offering summer camp opportunities with our partner schools. In 2020 though we had to pivot our programs due to COVID. We wanted to make sure that we still offered our summer camp host-site schools lunches over the summer and activities. So we developed four virtual summer camps and created kits for youth to pick-up. Virtual camps served 180 youth. Additionally, between our two sites we served 2056 lunches to youth over the summer. Our miscellaneous programs capitalize on opportunities to support programs outside of our core programs, like the Explorer Program which is sponsored by Clark County Sheriff's Office for students ages 15-1/2 to 21 an opportunity to observe the criminal justice system. Explorers provide non-enforcement assistance to the Sheriff's Office and serve their community through a wide variety of functions. 18 youth served

We provide athletic programs to help kids stay active and promote healthy lifestyles. Athletics allows kids to learn sportsmanship, teamwork, and discipline. Our hope is kids will learn valuable lessons and life experience on the practice field that they can use in the classroom. We have a core group of 5-7 officers who support this programming, serving approximately 3-5 hours each. Due to COVID we were only able to offer our basketball season which ended right before shutdowns. In that program we served approximately 216 youth.

Literacy events are a staple program for PAL. Typically, this programs brings law enforcement to local elementary schools to give a safety talk, tour vehicles and specialty units like marine and K9, and then hand out books. Due to COVID, this program had to pivot to go virtual. Our officers recorded safety talks for us to share with schools, as well as recorded videos with their patrol cars and specialty units. We even had several officers record themselves reading stories that we shared with schools. Then for the book piece we offered schools a drive-thru/COVID friendly pick-up or dropped off books for their students. In 2020 we served 30 schools and gave out 3,000 books.
